## SECTION 4: FIRST AID MEASURES

<b>Eye Contact</b>	In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention immediately. Eyelids should be held away from the eyeball to ensure thorough rinsing. Check for and remove any contact lenses. Get medical attention.

## METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN UP

**Small spill** Eliminate all ignition sources. Stop leak if without risk. Move containers from spill area. Absorb with an inert material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

**Large spill** Eliminate all ignition sources. Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Dike spill area and do not allow product to reach sewage system and surface or ground water. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. ## SECTION 7: HANDLING AND STORAGE

### PRECAUTIONS FOR SAFE HANDLING

**Protective measures:** Put on appropriate personal protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Avoid breathing vapor or mist. Empty containers retain product residue and can be hazardous. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Do not reuse container. If during normal use the material presents a respiratory hazard, use only with adequate ventilation or wear appropriate respirator. Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not swallow. Aspiration hazard if swallowed. Can enter lungs and cause damage. Never siphon by mouth.

## Appropriate engineering controls

All activities involving chemicals should be assessed for their risks to health, to ensure exposures are adequately controlled. Personal protective equipment should only be considered after other forms of control measures (e.g. engineering controls) have been suitably evaluated. Personal protective equipment should conform to appropriate standards, be suitable for use, be kept in good condition and properly maintained. ## INDIVIDUAL PROTECTION MEASURES

Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing. ## SKIN PROTECTION

**Hand protection:** Wear chemical resistant gloves. Nitrile gloves. Do not re-use gloves. Protective gloves must give suitable protection against mechanical risks (i.e. abrasion, blade cut and puncture). Protective gloves will deteriorate over time due to physical and chemical damage. Inspect and replace gloves on a regular basis. The frequency of replacement will depend upon the circumstances of use. Consult your supervisor or Standard Operating Procedure (S.O.P) for special handling instructions.

**Body protection:** Use of protective clothing is good industrial practice. Cotton or polyester/cotton overalls will only provide protection against light superficial contamination that will not soak through to the skin. Overalls should be laundered on a regular basis. When the risk of skin exposure is high (e.g. when cleaning up spillages or if there is a risk of splashing) then chemical resistant aprons and/or impervious chemical suits and boots will be required. Wear suitable protective clothing. Footwear highly resistant to chemicals. When there is a risk of ignition from static electricity, wear anti-static protective clothing. For greatest effectiveness against static electricity, overalls, boots and gloves should all be anti-static. When there is a risk of ignition wear inherently fire resistant protective clothes and gloves. Work clothing / overalls should be laundered on a regular basis. Laundering of contaminated work clothing should only be done by professional cleaners who have been told about the hazards of the contamination. Always keep contaminated work clothing away from uncontaminated work clothing and uncontaminated personal clothes. When the risk of skin exposure is high (from experience this could apply to the following tasks: cleaning work, maintenance and service, filling and transfer, taking samples and cleaning up spillages) then a chemical protective suit and boots will be required. Personal protective equipment for the body should be selected based on the task being performed and the risks involved and should be approved by a specialist before handling this product.

**Other skin protection:** Appropriate footwear and any additional skin protection measures should be selected based on the task being performed and the risks involved and should be approved by a specialist before handling this product.

**Respiratory protection:** Use with adequate ventilation. Avoid breathing vapor or mist. If ventilation is inadequate, use a NIOSH-certified respirator with an organic vapor cartridge and P95 particulate filter. In case of insufficient ventilation, wear suitable respiratory equipment. ## **OTHER INFORMATION**

Aspiration of this material into the lungs can cause chemical pneumonia and can be fatal. Aspiration into the lungs can occur while vomiting after ingestion of this material. Possible cancer hazard, based on skin-painting studies using laboratory animals, involving continuous, long-term contact. Regular periodic self inspection of the skin is recommended, especially those areas subject to contamination. In the event of any localized changes in appearance or texture of the skin being noticed, medical advice should be sought without delay. Naphthalene has been reported to cause developmental toxicity in mice after oral exposure to relatively high dose levels, but developmental toxicity was not observed in NTP (National Toxicology Program) sponsored studies in rats and rabbits. Ingestion or inhalation of naphthalene can result in hemolysis and other blood abnormalities, and individuals (and infants) deficient in glucose-6-phosphate dehydrogenase may be especially susceptible to these effects. Inhalation of naphthalene may cause headache and nausea. Airborne exposure can result in eye irritation. Naphthalene exposure has been associated with cataracts in animals and humans.

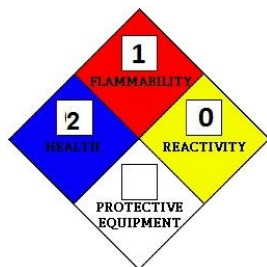
